What are Exemptions and am I eligible?

General Homestead (Owner Occupied) Exemption is available to owners who occupy a property as their principal residence on January 1 of the assessment year. The amount of the exemption is the difference between the 1977 equalized assessed value and the current assessed value. A reduction of up to \$6,000 in assessed value is provided.



Senior Homestead Exemption is for citizens 65 years and older who own and occupy their residences. A reduction of \$5,000 in assessed value is provided.

Senior Citizen Assessment Freeze
Homestead Exemption allows qualified senior citizens to elect to freeze the equalized assessed value of their property at the base year amount. To qualify for the assessment freeze homestead exemption, you must be 65 years of age or older, have a total household gross income (including Social Security) of no more than \$65,000.



Disabled Persons Exemption this allows qualified residents to lower the Equalized Assessed Value of your property by \$2,000. This can be claimed in addition to other exemptions.

- ★ To Qualify for this Exemption:
 - ⇒ Have a class 2 Illinois Person with Disability Identification Card from the Illinois Secretary of State's Office
 - ⇒ Proof of Social Security Administration Disability Benefits Award Letter
 - ⇒ A Physician's Statement (PTAX 343-A)

If you are unsure whether you qualify for or already have signed up for any of these exemptions, please call our office and we will happily go over them with you.



Residential Improvement Exemption is available to homeowners who improve their existing property. The exemption could delay the amount of increased assessed value up to 25,000 for a four-year period. The property must be owner-occupied.

Disabled Veteran's Exemption is available for Veteran's with Service-Connected Disability

- O 71% + (totally disabled) is exempt from property taxes with an EAV less than \$250,000
- o 50%-69% a reduction of \$5,000 in assessed value
- o 30%-49% a reduction of \$,2,500 in assessed value
 - ⇒ To qualify for this Exemption
 - Be an Illinois Resident
 - Have at least a 30% service-connected disability.
 - * Bring in the Veteran's DD-214
 - Bring in Veteran's Percentage of Disability from the US Department of Veteran's Affairs
- For 2023 Surviving Spouses can now apply for this exemption
 - ⇒ To qualify for this Exemption
 - Be an UN-REMARRIED spouse of a veteran
 - Must be an Illinois Resident
 - Bring in Veteran's Marriage Certificate
 - * Bring in Veteran's Death Certificate
 - Bring in Veteran's DD-214
 - Bring in Veteran's Percentage of Disability from the US Department of Veteran's Affairs

Senior Food & Denture Program -62 & older!


If you're a South Rock Island resident, are 62 or older, and income qualify, you may participate in our Senior Food or Denture Program. Seniors with a maximum income of \$1,800 per month (\$21,600 yearly) for one person, or a maximum of \$2,200 (\$26,400 yearly) for a twoperson household are eligible to apply. Those who meet all requirements could receive a \$40 monthly gift certificate to Hy-Vee. Under the same eligibility requirements, the Township

has a program for seniors to receive new or replacement dentures. *Individuals must not have dental insurance to apply*

To apply you must submit the following:

- Current piece of mail dated within the last 30 days (no junk mail)
- Current driver's license or state ID card showing residence in our **Township**
- Current Social Security statement
- Current bank statement
- Any other income from pensions or retirements, employment, or rental proper-
- Last years tax return

No appointment necessary. Come to the Township with your information, fill out a short application, and see if you qualify!



Please watch in the next edition of the newsletter for the special toy giveaway date and time and if you would like to donate any new/gently used toys please drop them off anytime during office hours.





IS YOUR HOME SAFE FROM LEAD-BASED PAINT?

Do you live in an older home that may have peeling paint or old windows? We can help make repairs to your home to make it lead (base paint) safe for your family.

Lead poisoning is a leading environmental illness of children and is caused primarily by lead-based paint in older homes. Although, substantial progress has been made in recent years, the State of Illinois maintains one of the highest rates in the nation for the number of children with elevated blood lead levels (EBLL's). Most recently, the State of Illinois reduced the EBLL threshold from 10 μg/dL to 5 μg/dL. The most common exposure to lead for children is through the ingestion of paint chips and contaminated dust from deteriorated or disturbed lead-based paint in homes built before 1978.

The City of Moline is the Responsible Entity (RE) who will serve as the central location (department) for this Illinois Quad Cities \$2,400,000 Lead Based Paint Hazard Reduction Grant Program and will be responsible for ensuring program compliance among the Illinois Quad Cities Healthy Homes Coalition (Coalition). The Coalition members carrying out the objectives in this new lead grant opportunity include: four local neighboring governments: City of Moline, City of Silvis, City of East Moline and the City of Rock Island; one Community Housing Development Organization, Project NOW, and the Rock Island County Health Department.



Every year we help sponsor the Rock Island Park and Recreation Egg Hunt at Lincoln Park. We enjoy giving to the youth of our community so much!







General Assistance Programs

General Assistance- Monthly

This program provides a basic needs allowance. All applicants must meet state mandated guidelines, and participate in the township's community work program or employment job search program.

Emergency Assistance

Once in a 12-month period, families with children, may receive aid to alleviate life threatening circumstances or to assist in attaining self sufficiency. Residents must produce a Late Notice.

For General and Emergency Assistance: All individuals and families must come to the township for a checklist and application, to see if they qualify.

Employment Assistance

Newly hired residents may qualify to receive job related supplies to begin their jobs. Applicants must provide proof of hire, ID, and the supplies required by the employer (i.e. uniform, steel toe boots, state ID/driver's license, etc.).

Unemployment Bus Tickets (yearly)

An unemployed resident may receive 20 free bus tickets in a 12-month period. An ID and current piece of mail dated within the last 30 days for proof of residency is required to obtain tickets. Junk mail and medical cards will not be accepted as a valid piece of mail.

Temporary Handicapped Placards

The placard offers parking privileges for those with temporary disabilities. Doctor's forms and placards are available at the Township. If you wish to obtain a permanent handicapped placard or license plate, you must mail your application to Springfield.


