Reports:

Frank Skafidas provided the Supervisor's Report *(Record)*. Skafidas stated that this year the Rock Island Parks & Recreation Department is asking for \$250 more for the Spring Egg Hunt, in partnership with Rock Island Township and the Rock Island Parks & Recreation Department.

A shred day is being planned for April for residents to safely dispose of sensitive documents.

The Township staff will continue to work on the Drug Take Back Day.

Skafidas stated that Supervisor Shirk would present the FY 2019 budget proposal at the February Township Board meeting.

Nick Camlin provided the Town Clerk's Report (*Record*). Town Clerk Camlin stated that he is beginning work on the Annual Town Meeting, and would need the agenda approved at the February Township Board meeting.

Nichole Finnie verbally provided the Assessor's Report. Assessor Finnie stated the County is informing residents of the new \$65,000/yr income standard for senior property tax freeze.

Skafidas provided the December 2017 General/Emergency Assistance Report for the Supervisor (*Record*). The December 2017 Client/Public/Senior Citizen Report was printed on the Agenda.

Treasurer's Report and Town Fund Bills:

Skafidas presented the Treasurer's Report for the Supervisor (*Record*). The Township Board audited the bills and claims (*Record*). Parr moved, and Sowards seconded, to authorize payment of the Town Fund and Relief Fund bills and transfers in the amount of \$41,405.12. Roll call vote. Four votes in favor: Parr, Sowards, Skafidas, and Elsberg. No votes in opposition. Motion carried.

The Assessor presented the FY 2019 budget proposal to the Township Board (*Record*). Assessor Finnie stated that the budget proposal includes a possible 2.5% salary increase for staff, pending job reviews. Overall the Assessor's budget increased by \$900 over FY 2018. The Township Board discussed raises, additional benefits, and training. Skafidas stated that he has different ideas for training and that he wants to discuss them at the February Township Board meeting.

Four votes in favor: Sowards, Skafidas, Elsberg, and Parr. No votes in opposition. Motion carried.

No action was taken on a request from Rock Island High School Athletic Department for a donation to the Ultimate Tailgate Party.

Parr moved, and Elsberg seconded, to donate \$250 to the Rock Island Parks & Recreation Department for the Spring Egg Hunt. Roll call vote. Four votes in favor: Skafidas, Elsberg, Parr, and Sowards. No votes in opposition. Motion carried.
