MINUTES OF THE MEETING SOUTH ROCK ISLAND TOWNSHIP BOARD

The South Rock Island Township Board met at the Office of the Town Clerk, located at 1019 27th Avenue, Rock Island, Illinois, on October 29, 2018, at 5:00 pm.

Approval of the October Agenda and Minutes of the September meeting:

Skafidas moved, and Elsberg seconded, to approve the Agenda (*Record*). Voice vote. Motion carried. Elsberg moved, and Skafidas seconded, to approve the September 24, 2018, Township Board meeting minutes. Voice vote. Motion carried.

Bi-Annual Review of Closed Session Meeting Minutes:

Elsberg moved, and Parr seconded, to adopt the Resolution regarding Open Meetings Act Review of Minutes of a Meeting Lawfully Closed (*Record*). Voice vote. Motion carried.

Reports:

Grace Diaz Shirk provided the Supervisor's Report (*Record*). Supervisor Shirk reported that no bids have been received for the 935 29th Avenue property. The Township Board discussed foregoing snow removal at the property. The Supervisor stated she would check costs for sidewalk snow removal, and that snow removal was not done at all last year. There was discussion about building Township Hall on that site and selling off current Township Hall.

The Township is now offering Matter of Balance class for seniors to help them with getting around, the Supervisor announced.

Supervisor Shirk reviewed newsletter costs with the Township Board. The total cost to the Township after ad sales, credits, and fees was \$3,161.61, which is a savings of over \$2,200 compared to the past.

Supervisor Shirk showed the Township Board the Committee's Choice trophy won by the Township staff for their entry in the Labor Day Parade.

There was discussion about senior citizen participants, which numbers 70. There was consensus among the Township Board to continue helping people and not have a cap on participants.

Supervisor Shirk stated that Township volunteers participated in the Drug Take Back Day on October 27, 2018.

Fall Fun is scheduled for October 31, 2018, from 12:30 to 3:30 pm at the Township Hall, and was publicized in the Township newsletter.

Supervisor Shirk informed the Township Board that the new website is scheduled to launch on November 1, 2018. NJS will continue to host the Township email at a cost of \$15 to \$18 per account, versus Google and Microsoft at \$50 per account.

The Supervisor stated that K-Mart is not accepting vouchers from Township clients anymore. Target in Moline has agreed to take on client vouchers.

Nick Camlin verbally presented the Town Clerk's Report (*Record*). Town Clerk Camlin reported that the AFR was filed with the County Clerk on September 28, 2018, and the Certification of Publication of the availability of the audit report was filed with the County Treasurer and County Clerk on October 19, 2018.

Nichole Finnie provided the Assessor's Report (*Record*). The Assessor distributed samples of the Welcome Letter being sent to new Township residents.

MINUTES OF THE MEETING

The Supervisor provided the September 2018 General/Emergency Assistance Report (*Record*). The September 2018 Client/Public/Senior Citizen Report was printed on the Agenda.

<u>Treasurer's Report and Town Fund Bills</u>:

The Supervisor presented the Treasurer's Report (*Record*). The Township Board audited the bills and claims (*Record*). Parr moved, and Skafidas seconded, to authorize payment of the Town Fund and Relief Fund bills and transfers in the amount of \$73,823.01. Roll call vote. Five votes in favor: Parr, Sowards, Skafidas, Elsberg, and Shirk. No votes in opposition. Motion carried.

Unfinished Business:

The Supervisor announced again that there were no bids and therefore no action to take. There was discussion on employing a realtor.

New Business:

No action was taken on requests for donations from Riverbend Food Bank or Friendship Manner.

Public Comments:

Skafidas announced that his mother, Effie Skafidas has passed away on Sunday, October 28, 2018. Skafidas told the Township Board about a project by American Bank over the weekend that provided \$2,500 worth of food to 166 families at Early Hansen Elementary School.

Skafidas stated that Supervisor Shirk and the Township are doing a great job with taxes; many other boards and councils are raising taxes and people don't like it.

At 5:54 pm Sowards moved, and Skafidas seconded, to adjourn the meeting. Voice vote. Motion carried.

The financial statements are prepared in accordance with the cash basis of accounting, a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America.

The accompanying annual appropriations listing of South Rock Island Township for the year ending March 31, 2019 has not been compiled or examined by us, and accordingly, we do not express an opinion or any other form of assurance on it.

The Township has elected to comply with the provisions of GASB Statement No. 34, Basis Financial Statements – and Management's Discussion and Analysis – for State and Local Governments, as amended and interpreted. This requires that the Township reflect its fixed assets net of depreciation. The balance reflected is from their March 31, 2018 Illinois Annual Financial Report.

Management has elected to omit substantially all of the disclosures ordinarily included in financial statements prepared in accordance with the cash basis of accounting. If the omitted disclosures were included in the financial statements, they might influence the user's conclusions about the government's assets, liabilities, fund balances, revenues, and expenditures. Accordingly, the financial statements are not designed for those who are not informed about such matters.
