The South Rock Island Township Board met at the Township Clerk's Office, 4330 11th Street, Rock Island, IL, on May 18, 2020, at 4:30 pm.

Roll Call:

Officials present: Supervisor Grace Diaz Shirk, Trustee Christine Elsberg, Trustee Mark Parr, Jr, Trustee Frank Skafidas (present by phone as allowed by the Governor's Executive Order), and Trustee Bill Sowards. No officials absent. Township Clerk Nick Camlin noted the presence of a quorum. Assessor Nichole Parker was also present.

Approval of the Agenda and Meeting Minutes:

Elsberg moved, and Sowards seconded, to approve the Agenda (*Record*). Voice vote. Motion carried. Parr moved, and Elsberg seconded, to approve the April 27, 2020, Township Board meeting minutes. Voice vote. Motion carried.

Reports:

Supervisor Shirk recognized Austin Montgomery of Mel Foster for a presentation regarding listing the Township property at 1019 27th Avenue, Rock Island, IL, with a realtor. Mr Montgomery reviewed potential marketing strategies and an assessment of comparable sales. He stated that he is authorized to offer 6% commission for the sale of the Township property, which includes buyer & listing broker. It would then be his job to look for buyers who match the building. Supervisor Shirk asked about advertising and showings, and Mr Montgomery replied that he would handle everything through closing.

Supervisor Shirk recognized David Levin of Ruhl & Ruhl for a presentation regarding listing the Township property at 1019 27th Avenue, Rock Island, IL, with a realtor. Mr Levin provided some of his career background to the Township Board, stating that he lives in Rock Island. He stated that he knows the Township building very well and knows the 11th Street area very well. Mr Levin also offered 6% commission, with all the marketing and expenses included. Mr Levin provided comparables, though acknowledged that Rock Island property tends to stay on the market for a while. Advertising is done on a national and international basis.

Grace Diaz Shirk presented the Supervisor's Report (*Record*). Switching the telephones to Hughes has saved an average of \$195 per month, reported Supervisor Shirk.

The Supervisor provided copies of the correspondences with Hammond Property Investments and Attorney John Redlingshafer, regarding the Termination of Contract to Purchase 1019 27th Avenue, Rock Island, IL (*Record*).

Supervisor Shirk stated that she is planning to have full staff return with full hours of operation beginning June 1, 2020, after the partial shutdown due to the COVID-19 pandemic.

The Shred Day is planned for May 29, 2020, from 9:30 to 11:30 am, at the Township Hall.

The Supervisor informed the Township Board that empty bottles were found on the grounds and security footage confirmed that unauthorized persons were on Township property and potentially using drugs. Rock Island Police will have more presence around the Township Hall.

The Township Board discussed a program to assist residents with disabilities to install ramps at their homes. There was consensus to offer a grant program with a flat award of \$1,000 toward a ramp, with no further involvement from the Township.

Nick Camlin provided the Township Clerk's Report (Record).

Nichole Parker provided the Assessor's Report (Record).

The Supervisor reviewed the April 2020 General/Emergency Assistance Report (Record).

The April 2020 Client/Public/Senior Citizen Report was printed on the Agenda.

Treasurer's Report and Town Fund Bills:

The Supervisor provided the Treasurer's Report for April 2020 (*Record*). The Township Board audited the bills and claims (*Record*). Sowards moved, and Elsberg seconded, to authorize the payment of the Town Fund and Relief Fund bills and transfers in the amount of \$49,464.79. Roll call vote. Five votes in favor: Elsberg, Parr, Skafidas, Sowards, Shirk. No votes in opposition. Motion carried.

The Township Board discussed listing the Township property for sale through a realtor. Clarification on accepting a bid at a minimum of 80% of the appraisal and how realtor commission factor into the selling price. Our law firm serves as legal counsel for South Rock Island Township, a unit of government of Rock Island County, Illinois (the "Township"). The Township advises you are no longer interested in purchasing Township property located at 1019 27th Avenue, Rock Island, despite earlier attempts to renegotiate the terms of the original Real Estate Sales Contract (the "Contract").

Specifically, we were made aware of an email from your company from April 16, 2020, that states "we will have to let the building go. You can put it back up for sale." A copy of this email is attached for your reference.

It is our understanding the Township responded to your email with one final attempt to renegotiate the sale, but you have not responded to that email or any other communications from the Township. This letter will serve as formal notice that the Township rescinds any such offers to renegotiate after your email of April 16, 2020, and hereby acknowledges your decision to terminate the Contract. Accordingly, the Township will be putting the property back on the market to look for a new buyer.

Consistent with paragraph 4 of the Contract, your "non-refundable money deposit" shall be retained by the Township.

Please contact this office within the next seven (7) calendar days with any questions regarding this letter. Otherwise, the Township will consider this matter closed and the Contract terminated.

Hello Grace,

That counter-offer puts us at an even greater risk of loss than we are currently facing. There are too many things out of our control, due to the virus and the country continuing to get more and more locked down. We find that everything is a "no" or a delay when we try to move forward, so we are not confident at all that in 2.5 more months we can have all the approvals we need and have the business set up completely. Under normal circumstances we could feel confident. These are not normal circumstances.

We would like to voice that when we had all of the cash needed and the opportunity to purchase last year that we were willing to wait 5 months for your company to move out, without any extra benefits added for our side of the table. But now that we want 3 months to close, you want a total of \$15,000 risked for your comfort and security in the deal. This doesn't feel fair and certainly a \$10,000 additional non-refundable amount is excessive in covering what your utilities, taxes, and attorney costs will be.

A non-profit requiring that much from a small business which is trying to get up and running is curious to us. Why would you request more to be at risk instead of understanding the difficulties we are currently up against with business shut downs, very limited access to government offices, and the country going crazy, instead of being grateful we did not just walk away without trying to still make it all work?

We would have gladly stayed in fighting for it to work for 3 months, but given that the board wants that much more money to go along with the extension, we will have to let the building go. You can put it back up for sale. It is not wise for us to risk even more than we have already lost.

We hope that if it is still available when the state opens up completely and people can get back to "business as usual", that you all would be willing to let us buy it at that time.

- 4. Accepting a bid: Township Board (*Trustees*) votes to accept a bid and authorizes the Supervisor and Township Clerk to execute the closing.
