The South Rock Island Township Board met at the Township Clerk's Office, 4330 11th Street, Rock Island, IL, on November 27, 2023, at 4:15 pm.

Roll Call:

Officials present: Supervisor Grace Diaz Shirk as Chair, Trustee Mark Parr, Jr, Trustee Frank Skafidas, Trustee Bill Sowards, and Trustee KJ Whitley. No officials were absent. Township Clerk Nick Camlin reported the presence of a quorum. Assessor Nichole Parker was also present.

Approval of the Agenda and Meeting Minutes:

Sowards moved, and Whitley seconded, to approve the Agenda (*Record*). Voice vote. Motion carried. Parr moved, and Skafidas seconded, to approve the October 30, 2023, Township Board meeting minutes. Voice vote. Motion carried.

Reports:

Grace Diaz Shirk provided the Supervisor's Report (*Record*). The Supervisor reported that the Veterans Luncheon had the largest turnout, with 217 participants, at a cost of \$1,322.12 to the Township.

Supervisor Shirk told the Township Board about emergency general assistance granted to Bethany Homes for an egress window at a home in the Township at a cost of \$3,650.

The Supervisor stated that she would like to bid for windows at the Township Hall in the future. Effective December 1, 2023, general assistance will increase to \$425 for clients.

The Senior Christmas Party is scheduled for December 4, 2023, and the Sassy Seniors Christmas Party is scheduled for December 18, 2023.

The Township is hosting a special toy Giveaway for children on December 14, 2023, and the last free Giveaway of the year is on December 19, 2023.

Supervisor Shirk recognized Whitley for donating a TV, soundbar, and stand to the Township Hall.

The Supervisor and Township Board discussed the meetings in January and February 2024 since some Township Board members will be out of town during the scheduled meetings.

Supervisor Shirk and Assessor Parker discussed replacement phones for the Township Hall.

Nick Camlin provided the Township Clerk's Report (*Record*). The Clerk informed the Township Board about a FOIA received on November 27, 2023, and responded to the same day.

Nichole Parker provided the Assessor's Report (*Record*). The Assessor stated that the deadline for issuing Certificates of Error on property assessments is December 13, 2023.

The Supervisor reviewed the October 2023 General/Emergency Assistance Report (*Record*). The October 2023 Client/Public/Senior Citizen Report was printed on the Agenda.

Treasurer's Report and Town Fund & Relief Fund Bills:

The Supervisor provided the Treasurer's Report for October 2023 (Record).

The Township Board audited the bills and claims *(Record)*. Whitley moved, and Sowards seconded, to authorize the payment of the Town Fund and Relief Fund bills and transfers in the amount of \$70,093.80. Roll call vote. Five votes in favor: Parr, Skafidas, Sowards, Whitley, and Shirk. No votes in opposition. Motion carried.

Unfinished Business:

Supervisor Shirk moved, and Sowards seconded, to approve the revised Township Board meeting dates for 2024 correcting the January meeting to January 8, 2024, and the Annual Town Meeting to April 9, 2024 *(Record)*. Roll call vote. Five votes in favor: Parr, Skafidas, Sowards, Whitley, and Shirk. No votes in opposition. Motion carried.

New Business:

Sowards asked to put the bids for fences back on the agenda for consideration.

Skafidas moved, and Sowards seconded, to approve for display and final adoption in December the Tax Levy Ordinance 2023-3 at a 0% increase with Certificate of Tax Levy & Truth in Taxation Certificate of Compliance *(Record)*. The aggregate levy did not have an increase over the prior year's extension, therefore a notice and hearing are not necessary. Voice vote. Motion carried.

Parr moved, and Skafidas seconded, to approve new telephones for the Township Hall through Hughes Telephone, Moline, IL, in the amount os \$1,894 for phones and \$813.50 for installation. Roll call vote. Five votes in favor: Parr, Skafidas, Sowards, Whitley, and Shirk. No votes in opposition. Motion carried.

No action was taken on a request for a donation from Rock Island - Milan Little League pending a review at the next meeting.

Sowards moved, and Whitley seconded, to donate up to \$2,000 to the Fraternal Order of Eagles (FOE), Rock Island, IL, for an AED, with the stipulation that it be returned if the FOE ever vacates the location. Roll call vote. Five votes in favor: Parr, Skafidas, Sowards, Whitley, and Shirk. No votes in opposition. Motion carried.

Public Comments:

Supervisor Shirk stated that she spoke to refugees about offering English classes at the Township Hall.

Adjournment:

At 5:41 pm Sowards moved, and Parr seconded, to adjourn the meeting. Voice vote. Motion carried.
