MINUTES OF THE MEETING SOUTH ROCK ISLAND TOWNSHIP BOARD MONTHLY AUDIT

The South Rock Island Township Board met at the Office of the Town Clerk, located at 1019 27th Avenue, Rock Island, Illinois, on October 24, 2016, at 5:00 pm.

Approval of the October Agenda and Minutes of the September meeting:

Alongi moved, and Shuda seconded, to approve the Agenda (Record). Voice vote. Motion carried.

Parr moved, and Shuda seconded, to approve the September 26, 2016, Township Board minutes. Voice vote. Motion carried.

Reports:

Grace Diaz Shirk provided the Supervisor's Report (*Record*). Supervisor Shirk presented a check in the amount of \$500 to Boy Scouts Troop #258 for landscaping work around the Township Hall.

The Supervisor reminded the Township Board about the blood drive at the Township Hall scheduled for October 26, 2016, from 11:00 am to 1:30 pm.

The Township staff will be participating in Fright Night, passing out bookmarks and leftover materials from Township Day, as well as sacks from RICAP. Fright Night is scheduled for October 27, 2016, 5:00 to 8:00 pm.

The Supervisor presented updated Emergency Assistance Program Guidelines, based on 2016 HHS Poverty Guidelines (*Record*).

On October 31, 2016, Township staff will visit school classrooms for Halloween.

The Township was solicited for a donation to the Rock Island Public Library Foundation's fundraising event "Food for Thought" taking place on November 10, 2016 (Record). There was consensus among the Township Board to support the fundraiser for up to \$100 without opposition.

Supervisor Shirk announced that the Rock Island County Area Project is shutting down December 31, 2016. The state granted \$50,000 to RICAP for this fiscal year, though they have traditionally received \$200,000, and therefore the board of directors decided to disband. The Supervisor wants to look at options for the Township-owned property without RICAP leasing, including possibly using or repurposing, leasing, or selling. The Supervisor asked the Township Board to come back with ideas at next month's meeting. RICAP was a partner in Try-Play and the Township will be picking up their role with providing the help for children.

Nick Camlin verbally presented the Town Clerk's Report. Town Clerk Camlin stated that last month the Annual Financial Report was filed with the County Clerk, a notice of its availability was published in the newspaper, and the County Clerk and County Treasurer received copies of the certificate of publication (Record).

Nichole Finnie provided the Assessor's Report (*Record*). Assessor Finnie stated that working through lunch hours has not been worth it since there have been maybe 15 people in the three week trial period.

The Assessor raised the possibility of reimbursing staff for milage when they are reviewing and photographing properties. Assessor Finnie stated that the goal is to get new pictures for all properties. The Township Board will consider in November whether to pay mileage reimbursements in FY18.

The Supervisor provided the September 2016 General/Emergency Assistance Report (Record).

The September 2016 Senior Citizen/Disabled Report was printed on the Agenda.

Treasurer's Report and Town Fund Bills:

Supervisor Shirk provided the Treasurer's Report (*Record*). The Township Board audited the bills and claims (*Record*). Parr moved, and Shuda seconded, to authorize payment of the Town Fund and Relief Fund bills and transfers in the amount of \$169,452.27. Roll call vote. Five votes in favor: Parr, Shuda, Skafidas, Alongi, and Shirk. No votes in opposition. Motion carried.

Supervisor Shirk moved, and Skafidas seconded, to approve the resolution for OMA Review of Minutes of a Meeting Lawfully Closed (*Record*). Town Clerk Camlin explained that at least every six months, minutes of closed sessions must be reviewed to determine if they can be made open to the public. He advised that the closed session from December 21, 2015, for personnel matters still requires confidentiality. Voice vote. Motion carried.

Alongi moved, and Shuda seconded, to adopt Ordinance No. 2014-4, Local Government Travel Expense Control (*Record*). Voice vote. Motion carried.

No action was taken on the Rock Island-Milan Little League Scholarships since Kevin Nolan did not respond in time.

No action was taken on donation requests from the Rock Island-Milan Education Foundation and Friendship Manor.

We did not audit or review the financial statements nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by management. Accordingly, we do not express an opinion, a conclusion, nor provide any form of assurance on these financial statements.

The financial statements are prepared in accordance with the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America.

The accompanying annual appropriations listing of South Rock Island Township for the year ending March 31, 2017 has not been compiled or examined by us, and accordingly, we do not express an opinion or any other form of assurance on it.

The Township has elected to comply with the provisions of GASB Statement No. 34, Basis Financial Statements – and Management's Discussion and Analysis – for State and Local Governments, as amended and interpreted. This requires that the Township reflect its fixed assets net of depreciation. The balance reflected is from their March 31, 2016 Illinois Annual Financial Report.

Management has elected to omit substantially all of the disclosures ordinarily included in financial statements prepared in accordance with the cash basis of accounting. If the omitted disclosures were included in the financial statements, they might influence the user's conclusions about the government's assets, liabilities, fund balances, revenues, and expenditures. Accordingly, the financial statements are not designed for those who are not informed about such matters.

ORDINANCE NO. 2016-4

AN ORDINANCE ESTABLISHING THE REIMBURSEMENT OF ALL TRAVEL, MEAL, AND LODGING EXPENSES OF OFFICES AND EMPLOYEES IN THE TOWNSHIP OF SOUTH ROCK ISLAND, ILLINOIS

WHEREAS, SOUTH ROCK ISLAND Township, Rock Island, County, Illinois is a non-home rule unit of local government pursuant to Article VII, § 8 of the 1970 Illinois Constitution;

WHEREAS, the Local Government Travel Expense Control Act, Pub. Act 99-0604, requires all non-home rule local public agencies, including townships, to regulate, by ordinance or resolution, the reimbursement of all travel, meal, and lodging expenses of their officers and employees by the effective date January 1, 2017; and

WHEREAS, the Board of Trustees has determined that it must comply with the Act by passage of this ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF SOUTH ROCK ISLAND TOWNSHIP, ROCK ISLAND COUNTY, ILLINOIS, THAT THE FOLLOWING ORDINANCE TO REGULATE THE REIMBURSEMENT OF ALL TRAVEL, MEAL, AND LODGING EXPENSES OF THEIR OFFICERS AND EMPLOYEES BE AND HEREBY IS ADOPTED:

SECTION I.: Definitions.

The following words, terms and phrases, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

<u>Entertainment:</u> includes, but is not limited to, shows, amusements, theaters, circuses, sporting events, or any other place of public or private entertainment or amusement, unless ancillary to the purpose of the program or event.

<u>Travel:</u> any expenditure directly incident to official travel by employees and officers of the Township or by wards or charges of the Township involving reimbursement to travelers or direct payment to private agencies providing transportation or related services.

SECTION II: Official Business for which Expenses May Be Reimbursed.

- (1) An Official of the Township shall be entitled to reimbursement for travel, including meals or lodging, related to the following types of official business:
 - a. Education conferences related to the duties of the officer of the Township;
 - b. Site visits to current or potential vendors of the Township

SECTION III: Maximum Allowable Reimbursement for Expenses.

(1) The maximum allowable reimbursement for an employee or officer of the Township shall be those rates set according to the Travel Policy established by the Board of Trustees of SOUTH ROCK ISLAND TOWNSHIP on August 26, 2013 and updated on January 25, 2016. The Policy will identity other guidelines for travel.

SECTION IV: Approval of Expenses.

The Travel Policy approved by the Board of Trustees and updated as of January 25, 2016 shall be used to determine approval of expenses. At monthly Township meetings, by a roll call vote at an open meeting the Board of Trustees shall have the final approval of all travel expenses with the approval of the monthly bills.

SECTION V: Documentation of Expenses.

Before a reimbursement for travel, including meals or lodging, may be approved pursuant to Section IV,

a standardized form for submission of travel, meal, and lodging expenses supported by the following minimum documentation shall first be submitted to Supervisor of said employee or official:

- (1) An estimate of the cost of travel, meal, or lodging if expenses have not been incurred or a receipt of the cost of travel, meals, or lodging if the expenses have already been incurred;
- (2) The name of the individual who received or is requesting the travel, meal, or lodging expense;
- (3) The job title or office of the individual who received or is requesting the travel, meal, or lodging expense; and
- (4) The date or dates and nature of the official business in which the travel, meal, or lodging expense was or will be expanded.

All documents and information submitted under this Section are public records subject to disclosure under the Freedom of Information Act, 5 ILCS 140/1

SECTION VI: Entertainment Expenses.

No employee or officer of the Township shall be reimbursed by the Township for any entertainment expense.

SECTION XII: Effective Date.

This Ordinance shall be in full force and effect from and after its passage. It shall remain in effect until a new ordinance is established. It is understood, that if the SOUTH ROCK ISLAND TOWNSHIP TRAVEL POLICY IS UPDATED, THIS ORDINANCE SHALL APPLY TO THE MOST RECENT VERSION OF THE TRAVEL POLICY AS APPROVED BY THE TOWNSHIP BOARD OF TRUSTEES.
